Ten Tips for Appraisers Working with Trust and Estate Attorneys November 7, 2014 By Rick Warner, ASA



On Friday, November 7, the Chicago Chapter of the American Society of Appraisers hosted Mary Lee Turk of Levin Schreder & Carey, Ltd. for a presentation titled "Ten Tips for Appraisers Working with Trust and Estate Attorneys". This presentation was offered as part of the Personal Property Valuation Principles Course, PP/GJ 204: The Legal and Commercial Environment.

Ms. Turk's presentation, made to a sold out audience including appraisers from all disciplines, discussed how attorneys and appraisers could work together to meet the needs of their mutual clients. Issues discussed included what is a "qualified appraisal", why an appraiser's credentials are important and what attorneys are looking for from appraisers that they hire.

Regardless of what appraisal discipline you are part of; this was an excellent session and one that you should consider attending in the future.

2014 ASA-CICBV Business Valuation Conference October 27-29, 2014, Toronto Canada

By all accounts the Chicago Chapter was well represented at the recent ASA-CICBV conference held in Toronto on October 27-29th. Feedback from several of our members is as follows:

- Facilities at the Westin Harbour Castle on the shores of Lake Ontario were uniformly praised;
- No real logistical issues getting into Canada, although one keynote speaker reportedly left his passport in a cab (said speaker was filled in for by Amanda Lang, senior business correspondent at CBC; some suggested that her keynote address was perhaps the best session of the conference);
- Other notable presentations included the folks from Desjardins Securities and their presentation on the North American oil and gas industry; John Paglia, PhD, CFA, CPA and his presentation discussing differences between public and private capital markets; Eric Nath offered his thought provoking comments regarding the reliability of data that we look to when opining on discounts from Net Asset Value (for investment holding companies) and suggested that perhaps income and market approaches were better suited to the task; Mike Pelligrino did his usual outstanding job of discussing patent analysis and valuation; and the always popular Professor Damodaran spoke about the differences between price and value;
- The conference was well attended with estimates in the 650 700 attendee range, with the Canadians in the majority (70 percent or so...);
- Kudos to Bill Armitage and Bill Stamatis (and no doubt many others) on the planning committee for the conference, which according to all accounts was an outstanding success.
